IMPLEMENT

System Conceptual Design. Once you have made your selection, our team collaborates with you to design your solution. Design may focus on determining which modules and elements of those modules will be necessary to meet your requirements. At the design stage, the project team's ability to efficiently and cost effectively make changes is greater than at any other time in the project, so our team works closely with yours to identify use cases and the design focuses on delivering on those.

System Implementation. MANAGE CHANGE
