Federal clients can sole-source a GSA order if it is below the micro-purchase threshold of \$2,500, with documentation of the circumstances if is between \$2,500 and the simplified acquisition threshold of \$150,000, or with a limited-sources justification if it exceeds the \$150,000 threshold. An order exceeding the \$150,000 threshold requires that you distribute an RFQ/RFP to multiple schedule contractors (typically 3) as practicable usually through the GSA eBuy System-in order to receive at least three competitive quotes on the RFQ/RFP.

The steps to using a GSA Schedule are:

- Develop a scope of work and transmit it to your contracting support staff. (If you do not know who that is, let us know and we will assist you)
- The contracting staff prepares an RFP and transmits it to AECOM and at least 2 other GSA Schedule holders through eBuy.
- 3) AECOM responds to your RFP with a proposal.
- 4) Technical and contracting staff review our proposal, and if necessary, clarify or negotiation with us. (Since GSA schedule have set labor rates and terms and conditions, this process is quick and simple.
- 5) Contracting staff issues a task order.
- 6) AECOM completes the order.
